### **Justification:**

### 1. IFWF Update:

a. In 2023, IFWF received \$26,666, the remainder of the Magic Valley estate. The funds were designated to be used for public access. IFWF worked with Department staff to put out an RFP to regions for project funding.

The Clearwater Region was awarded the funds to be utilized for the following:

Winchester Lake: parking lot resurfacing. This access point receives more effort than any other lowland lake in the Clearwater Region. The main parking area was paved over 25 years ago, and now has reached a condition where it is riddled with potholes and anglers are complaining about it.

This project would entail pulling up all the old pavement and hauling it away and then resurfacing the parking lot with gravel.

- b. IFWF Competitive grant cycle closed April 30<sup>th</sup>. The IDFG Regional Competitive grant cycle closes May 30<sup>th</sup>.
- c. IFWF will hold the next quarterly meeting on August 9-10th in Soda Springs, Idaho.
- 2. Wildlife License Plate Update

The wildlife license plates continue to see growth year after year, especially with renewals. Total sales (new and renewal) from 2021-2023 increased by 16,261. All plates (new and renewal) are showed growth in 2023.

Elk- 8,283, 7.11% increase from 2022 Trout- 4,936, 3.31% increase from 2022

Overall new total increase 7.04% increase from 2022

Bluebird- 19,688, 14.71% increase over 2022 Elk- 31,370, 14.96% increase over 2022 Trout- 16,761, 16.32% increase over 2022

Overall renewal total increase 15.22% increase over 2022.
