**MISCELLANEOUS**

**Public Meeting**

Chairman Ron Davies called the meeting to order at 7:00 p.m. MDT and reviewed the rule of conduct for the hearing and reported that all public comments would be reviewed by the Commission at the Wednesday business meeting. Commissioner Dave Bobbitt, Don Ebert, Tim Murphy, Greg Cameron, Jordan Cheirrett, Brody Harshbarger, and Ron Davies were present.

**MISCELLANEOUS**

Chairman Davies called the meeting to order at 8:00 am MDT.

**Review of Public Comment**

Director Fredericks provided a summary of the public comments. There were 40 members of the public in attendance with 22 people providing testimony.

- Three people provided testimony in support of the Goose zone configurations for the 2025-2026 hunting season.
- The President and Vice-president of the Idaho Wild Sheep Foundation expressed their support and appreciation for the Bighorn Sheep Auction and Lottery tags program.
- Eastern Idaho Houndsman Association expressed appreciation for the Commission Challenge Grant opportunity and looking forward to the Commission decision on this year's Challenge Grants.
- Twelve people provided testimony with concerns of advancement of hunting technology and how this technology impacts fair chase and ethical hunting. There was specific testimony requesting a rule change to prohibit scopes greater than 9 power or range finders with more than 500-yard ranges. They asked the Department to think about advancing hunting technology practically and proactively.

- One person commented that the limits on hunting technology should not be limited to just long-range hunting but should include thermal imaging binoculars and trail cameras.
- Two people provided testimony suggesting range finders can assist hunters confirm they are shooting within their effective range.
- The President of the National Wild Turkey Federation of Idaho thanked the Commission for the support of their organization.
- One person provided testimony asking the Department to consider charging non hunters and anglers an access fees at Department access sites and wildlife management areas.

#### **FY 26 Budget Approval**

Jon Oswald, Administration Bureau Chief, presented the FY 26 budget forecast (Appendix 57, Exhibit 56).

**24-51** Commissioner Bobbitt moved that the Commission approve the State Fiscal Year 2026 budget request as presented and allow the Department to modify the request as necessary for minor administrative items if they arise. Commissioner Harshbarger seconded. Motion Carries.

#### **Administrative Rules: Adoption of Proposed Rules – Trapping of Wildlife and Taking of Furbearing Animals**

Deputy Director Amber Worthington, presented (Appendix 57, Exhibit 57). Due to unforeseen, late-breaking concerns around certain proposed language in the rule, the Commission was asked to keep IDAPA 13.01.16 open for another year. With no objection from the Commission, staff will keep this chapter open for the next year to address concerns.

#### **Administrative Rules: Adoption of Proposed Rules – Rules Governing Taking of Wildlife, GMZ Descriptions**

Deputy Director Amber Worthington, presented (Appendix 57, Exhibit 58).

**24- 52** Commissioner Cheirrett moved the Commission adopt the proposed rule as presented, with authority for the Department to make non-substantive edits in the proofreading process that do not alter the sense, meaning or effect of the rules. Commissioner Cameron seconded. Motion carries.

**2025 – 2027 Fishing Seasons and Limits Season Setting**

Lance Hebdon, Fisheries Bureau Chief, presented (Appendix 57, Exhibit 61).

**24-55** Commissioner Cameron moved the Commission adopt the Idaho Fishing 2025 – 2027 Seasons and Rules as proposed. Commissioner Murphy seconded the motion. Motion carries.

**2024 Sage-grouse Season Setting**

Jennifer Struthers, Staff Biologist, presented (Appendix 57, Exhibit 62).

**24-56** Commissioner Cameron moved the Commission adopt staff recommendations for the 2024 sage-grouse hunting seasons and bag and possession limits, including bag and possession limits for take by falconry. Commissioner Murphy seconded the motion. Motion carries.

**Falconry: Sage-grouse Tag Use for End of 2024 Season/Discount Order**

Jennifer Struthers, Staff Biologist, presented (Appendix 57, Exhibit 63).

**24-57** Commissioner Cameron moved that the Commission adopt the discount order for sage-grouse tags for falconry as presented. Commissioner Cheirrett seconded the motion. Motion carries.

**2025 – 2026 Nonresident Tag Limits and 2025 Outfitter Allocation**

Rick Ward, State Wildlife Manager, presented (Appendix 57, Exhibit 64).

**24-58** Commissioner Cheirrett made the following motion:

“I move the Commission adopt staff recommendations for managing nonresident general season uncapped Elk Zone A and B tags and regular and white-tailed deer tags as presented by staff in the summary tables.”

Commissioner Bobbitt seconded the motion. Motion carries.

**24-59** Commissioner Bobbitt made the following motion:

“I move the Commission set aside 2,975 general season elk tags and 1,846 general season deer tags from the 2025 statewide nonresident limits for sale to persons that have entered into an agreement to use the services of a licensed outfitter.”

Commissioner Harshbarger seconded the motion. Motion carries.

**24-60** Commissioner Ebert made the following motion:

“I move the Commission adopt staff recommendations for 2025 outfitter tag allocation and 2025 general-season tag limits for nonresidents for elk zones and deer units that are unlimited for residents, as presented by staff in the summary tables.”

Commissioner Cameron seconded the motion. Motion carries.

**Release of Bighorn Sheep Tags for Auction and Lottery**

**24-61** Commissioner Cameron moved the Commission release the 2025 bighorn sheep auction tag to the Wild Sheep Foundation to conduct an auction and the 2025 bighorn sheep lottery tag to the Idaho Wild Sheep Foundation to conduct a lottery. Commissioner Cheirrett seconded the motion. Motion carries.

**Discount Order for Bighorn Sheep Lottery Tag Application**

**24-62** Commissioner Cameron moved the Commission adopt the discounted fees as presented by staff for all “Bighorn Sheep Lottery Tag” Special Controlled Hunt applications for the July 2025 and July 2026 drawing. Commissioner Murphy seconded the motion. Motion carries.

### **Crystal Summit Conservation Easement**

**24-65** Commissioner Bobbitt made a motion that the Commission acquire the 1,252 – acre Crystal Summit Conservation easement. Commissioner Cheirrett seconded the motion. Motion carries.

### **Spencer Property Donation**

## **SEASON SETTING AND RULES**

### **Controlled Hunt Post Card Notification Error**

Deputy Director, Amber Worthington presented the 2024 controlled hunt draw results for deer, elk, pronghorn, fall bear and fall turkey were incorrectly sent to hunters that were successful in the 2021 controlled hunt drawing. The Department relies on email notifications, emails, and hunters checking the “Go Outdoors App” to check results. Within 24 hours of the drawing 84,000 hunters, 45%, had checked their results through the App. There are approximately 3.2% of hunters who have no email address recorded in the system. These hunters rely on other forms of notification for their results. Correction letters and emails were sent to those hunters who were successful in the drawing this year. Director Fredericks suggested discontinuing the mailing due to the limited number of hunters without email addresses and the cost of the mailing. With no objection from the Commission, the Department will discontinue mailing post card results.

The Commission discussed litigation matters.


**24-68** Commissioner Ebert moved, and Commissioner Cameron seconded a motion that the Commission come out of executive session with no action taken. Motion carries.
