# **Public Meeting**

Chairman Don Ebert called the meeting to order at 7:00 p.m. PDT and reviewed the rule of conduct for the hearing and reported that all public comments would be reviewed by the Commission at the Wednesday business meeting. Commissioner Dave Bobbitt, Don Ebert, Tim Murphy, Greg Cameron, Jordan Cheirrett, and Ron Davies were present.

#### **MISCELLANEOUS**

Chairman Ebert called the meeting to order at 8:00 am PDT and welcomed Chairman Mendive of the House Resources and Conservation Committee.

#### **Review of Public Comment**

Director Fredericks provided a summary of the public comments. There were 30 members of the public in attendance with 17 people providing testimony.

- Three people provided testimony expressing support to increase the length limits from 20" to 24" on Chinook Salmon on Coeur d'Alene Lake to protect the 2 year old fish.
- Seven people provided testimony regarding spearfishing for gamefish in lakes with undesirable gamefish. This would require a rule change.
- One person provided testimony in support of liberalizing lake trout limits on Priest Lake and managing the lake as a more diverse fishery.
- Three people testified in support of F4WM funding and was disappointed in the wolf trapping ruling.
- Two people provided testimony against walleye reduction and asked for winter access on the North side of Lake Pend Oreille.
- There was also testimony provided on Coeur d' Alene Trap and Skeet Club with concerns on the deadline of fund appropriation.

#### Consent Calendar

**24-35** Commissioner Bobbitt made a motion to accept the consent calendar as presented. Commissioner Cheirrett seconded the motion. Motion carries.

# Commission Direction for the Wolf Depredation Control Board Funds

**24-37** Commissioner Murphy moved the Commission adopt staff recommendation for the Idaho Wolf Depredation Control Board to expend up to \$300,000 in management units/zones for the protection of ungulates and to address chronic livestock depredation. Commissioner Bobbitt seconded. Motion carries.

# Commission Direction for Animal Damage Control Board Funds

Tricia Hebdon, Assistant Wildlife Bureau Chief presented (Appendix 57, Exhibit 34).

24-38 Commissioner Cheirrett moved the Commission adopt staff recommendations to direct \$50,000 for general predatory wildlife control consistent with the Animal Damage Control Board MOU; \$25,000 for Department-authorized depredation control of black bears and mountain lions; and \$25,000 for Department-directed activities implementing Idaho's American White Pelican Management Plan. Commissioner Cameron seconded the motion. Motion carries.
