Background:

Regional staff scoped proposals for big game season changes, controlled hunt tag limits, and hunt boundary changes at open houses, public meetings, and through the Department's website during Feb 8-22. Following assessment of public input and final regional recommendations, regional staff will submit recommendations to the Wildlife Bureau and a final package of recommendations will be developed for the 2025 and 2026 hunting seasons for presentation to the Commission. Staff will also present recommendations for adjustments to Landowner Appreciation Program tags proportional to recommended changes to corresponding big game tag numbers.

Recommendations have not been finalized as of this writing, but a summary of preliminary proposals scoped with the public is attached. Following review of public input and consideration of any new population survey information, proposals may be modified or rescinded. Final recommendations will be presented to the Commission at the meeting.

Statutory Authority and/or Policy Issues:

Idaho Statute 36-104 authorizes the Commission to establish rules for the taking of wildlife consistent with state policy. Species management plans provide Commission direction for population and harvest management. This agenda item is to establish statewide big game hunting seasons for the 2025 and 2026 hunting seasons.

Public Involvement Process:

Recommendations have resulted from year-round public involvement and population and harvest monitoring. Proposals have been scoped internally and with the public through open houses and public meetings around the state, email outreach, and through the Department's website. Proposals were posted on the Department website and input was solicited from February 8-22. Public input will be evaluated and a summary will be provided during the presentation.

Justification:

Commission action is required to adopt 2025 and 2026 hunting seasons for mule deer, white-tailed deer, elk, pronghorn, black bears, mountain lions, and gray wolves. Commission action is also required to adopt the 2025 and 2026 Landowner Appreciation Program seasons.

Staff Recommendation:

After evaluation of public input, staff will develop final recommendations for the 2025 and 2026 hunting seasons. Those final recommendations will be presented to the Commission at the meeting. Staff recommends Landowner Appreciation Program hunts and tag levels be adjusted consistent with, and proportionate to, Commission adopted changes in regular controlled hunt timing, boundaries, and tag levels.

Suggested Motion:

Motion #1 - I move the Commission adopt staff recommendations for big game hunting seasons, tag numbers, and hunt boundaries for the 2025 and 2026 hunting seasons.

Motion #2 - I move the Commission adopt staff recommendations for the Landowner Appreciation Program seasons and tag numbers for 2025 and 2026 that are reflective of the 2025 and 2026 regular controlled hunt timing, boundaries, and tag levels.

 - Units 22 and 31: Allow use of dogs during Oct 1 - Oct 9, shift general hunts in Units 22 and 31 from “on or within one mile of private land” to “outside the National Forest System Boundary”, and allow use of dogs during Oct 1 - Oct 9 in Hunt Area 22-1 (Hunt No 8502 and Hunt No 8505).
- Magic Valley:
 - Units 52A and Unit 53: New bear hunting opportunity.
- Southeast:
 - Units 66A and 76: Extend take season to June 30.
 - Units 68, 68A, 70, 73 and 73A: Extend general spring and fall seasons.
 - Units 71, 72, 74, 75, 77 and 78: Extend take season to June 30.

MOUNTAIN LION

- Statewide:
 - Year-round, statewide mountain lion season (no change to hound hunting season dates).



IDAHO FISH AND GAME GOLDSHEET

- Clearwater:
 - Units 8 and 11A: add dogs prohibited Aug 30 – Sept 14.
 - Unit 10A: allow use of second lion tag.
 - Modification to the nonresident hound permits in the Selway Elk Zone. Combine the Selway Zone (Units 16A, 17, 19, and 20) and Unit 17-1.
- Magic Valley:
 - Unit 45: allow use of second mountain lion tag.
- Southeast:
 - Units 70, 73 and 73A: Allow use of hounds beginning Nov 1.
