North Idaho Timber Group Conditional Access Program

These rules apply to the private lands enrolled in North Idaho Timber Group Conditional Access Program <https://idfg.idaho.gov/access/north-idaho-group> in partnership with the Idaho Department of Fish and Game to provide hunting, fishing, and other recreational opportunities for the general public.

The North Idaho Timber Group lands are available for public access under lease agreements between the Idaho Department of Fish and Game and private landowners.

Compliance with these rules is a condition for landowners to allow of continued use of this property. Failure to comply with the conditions established for access may result in, loss of access privilege, criminal prosecution, financial penalties, and/or civil liability.

ETHICS AND RESPONSIBILITY

The lands enrolled in this program are **private lands**. *Respect for these lands and the property owners' rights is essential for the continuation of this program.*

LANDOWNER RULES TO BE FOLLOWED TO ENSURE CONTINUED USE OF THIS PROPERTY

- 1) All off-road motorized vehicle use is STRICTLY PROHIBITED. Violation may be subject to financial penalties and/or loss of hunting and fishing privileges under Idaho Statute 36-126.
- 2) Motorized travel is limited ONLY to roads open to full-sized vehicles. Motorized travel is prohibited on roads that are gated, barricaded, or designated as "restricted" or "closed". Violation may be subject to financial penalties and/or loss of hunting and fishing privileges under Idaho Statute 36-126. See associated map. Maps can be found at (map link) or acquired at regional IDFG offices.
- 3) Respect all gates. Some gates may be closed for administrative purposes by the landowner. Tampering with gates is expressly prohibited and may be subject to financial penalties under Idaho Statute 18-7001 – Malicious Injury to Property.
- 4) Camping is prohibited unless in designated areas identified with signs.
- 5) Open fires are prohibited unless in designated camping areas. All fires are prohibited during State closures for wildfire risk.
- 6) No trash or dumping on the property is permitted. Pack it in, pack it out.
- 7) Human waste must be packed out or properly buried at least 100 feet from open water.
- 8) Big game, unprotected, furbearer, and predatory animals may be hunted only from one-half hour before sunrise to one-half hour after sunset.
- 9) The use of screw in tree steps, pegs, spikes or nails is strictly prohibited.
- 10) Use of tracer bullets, other explosive ordinance, and fireworks is strictly prohibited.

- 11) With respect to hunting and trapping of wolf, the season dates, bag limits, laws, and rules applicable to public lands shall apply to North Idaho Timber Group lands with the exception of wolf hunting allowed during legal big game hunting hours only. More expansive seasons, limits, laws, and rules for private lands do not apply to North Idaho Timber Group lands.
- 12) Prohibited uses include cutting and removing wood, removing rocks, plants, or other native materials (with the exception of berries and mushrooms for personal use), or disturbing any stream, water body, or archaeological site.
- 13) Commercial outfitting or other commercial use of these lands of any kind is prohibited.
- 14) Access is prohibited during closures for wildfire risk or active harvest or road maintenance operations.
