- One person provided testimony that they would like to see a guaranteed tag for anyone who harvests a wolf in some units. They also expressed their concerns that the Non-Resident Tag Issuance Advisory Committee will be unable to get non-resident participation down to 10%.
- One person provided testimony asking the Department to change several controlled hunts in the Clearwater region that are antlered mule deer only, to be valid for white-tailed deer, as well.
- One person provided testimony asking the Department for a specific measure to combat precluded access due to continuous forest fires in Unit 20.

• Three people provided written testimony. One person regarding CWD in the Panhandle region. One person regarding wolf management. One person regarding several season-setting proposals for big game in the new year.
