

**Idaho Fish and Game Commission  
Special Meeting – February 27, 2025  
Idaho Department of Fish and Game  
Legislative Conference Call  
Boise, Idaho**

A meeting of the Idaho Fish and Game Commission was held by telephone conference, attended by Commissioners Dave Bobbitt, Don Ebert, Tim Murphy, Mike Roach, Jordan Cheirrett, Brody Harshbarger, and Ron Davies.

Chairman Davies called the meeting to order at 9:00 a.m. MST.

**LEGISLATION**

**Legislative Update (Commissioner Confirmations, IDFG Presentations, Bills, budget, Rulemaking, etc.)**

Amber Worthington provided updates on rulemaking and legislative developments.

The Chapter 7 review, initially scheduled for a Senate Resources vote, was postponed due to other priorities on the agenda. It has now been rescheduled for Wednesday, March 5<sup>th</sup>, 2025.

Commissioner Mike Roach's confirmation remains pending, with his nomination advancing to the third reading calendar daily. However, a final confirmation vote has not yet been scheduled.

HB 248, the base appropriation budget, continues to progress through the Senate but has not yet reached a final vote. Additionally, an enhancement budget bill has been referred to the Joint Finance-Appropriations Committee (JFAC) for review. A rules concurrent resolution remains under consideration by both legislative chambers, and a recent committee vote resulted in unanimous approval.

**New Bill Analysis for Discussion/Update on Pending Legislation / Action for Policy Position**

Ellary Tucker Williams provided the following updates on legislation.

HB 302 would significantly alter Idaho's wildlife translocation process by requiring county commissioner approval. Currently, the Idaho Department of Fish and Game (IDFG) relocates wildlife based on public safety concerns and conservation needs, with minimal bureaucratic delays. The bill mandates notifying affected landowners and public grazing permittees, who can


object and trigger a county commission hearing, potentially delaying or blocking relocations. IDFG warns that this could lead to increased euthanasia of wildlife due to a lack of holding facilities and hinder conservation efforts, game bird stocking, and endangered species recovery. Additionally, the bill may impose high costs on IDFG due to increased disease surveillance requirements and administrative burdens.

**25-19** Commissioner Bobbitt made a motion that the Commission does not support and testify on HB 302. Commissioner Harshbarger seconded the motion. Motion carries.
