## Purpose of Meeting/Agenda:

- 1 Rulemaking Petition (November 19, 2020) from Idaho Outfitters and Guides Association regarding the statewide limit for outfitter set-aside deer and elk tags. (Action Item)
- 2. Temporary rulemaking (subject to Governor's Office rulemaking approval) to increase the outfitter set-aside for elk tags from 2,400 to 2,800. (Action Item)
- 3. Evaluating potential use of set-aside tags to address impacts to use of outfitting services from faster elk/deer tag sales and sell-outs in zones/units limited for non-residents (those zones/units limited on November 20). (Discussion only)
