- 1 Rulemaking Petition (November 19, 2020) from Idaho Outfitters and Guides Association regarding the statewide limit for outfitter set-aside deer and elk tags. **(Action Item)**
- 2A. Temporary rulemaking (subject to Governor's Office rulemaking approval) to increase the outfitter set-aside for elk tags from 2,400 to 2,800. **(Action Item)**
- 2B. Revise 11-20-2020 proclamation distribution between outfitter-allocated and non-outfitted components of nonresident elk tag zone limits (only in zones that are unlimited for residents & limited for nonresidents). **(Action Item)**
3. Revise 11-20-2020 proclamation distribution between outfitter-allocated and non-outfitted components of nonresident deer tag unit limits (only in units that are unlimited for residents & limited for nonresidents). **(Action Item)**
