STIPULATIONS OF THE EDUCATIONAL FISHING PERMIT

Idaho Statute codifies that Educational Fishing permits may only be issued for “department-sponsored events”. Department sponsored is to be interpreted as: (1) the department plays a central role in the organization and planning of events; (2) event organizers or hosts must possess substantial knowledge of fishing and be competent in fishing instruction, and (3) hosts must possess an annual fishing license. Trout in the Classroom, Free Fishing Day, and Take Me Fishing Trailer events automatically qualify as department-sponsored events and hosts of these events are exempt from annual fishing license requirements.

SUBMISSION OF APPLICATION:

Application for an Educational Fishing permit should be submitted at least 10 business days prior to the event. Any missing information could delay processing. Applications should be submitted to the respective regional office:

PERMITTING PROCESS AND STIPULATIONS:

IDFG will notify the above-named person as to whether this application is approved. If approved, an Educational Fishing Permit will be issued to the lead instructor for the event, which will exempt event students from purchasing a fishing license (36-401(f)); however, all instructors will be required to have a valid fishing license during the event. All seasons, limits, and rules adopted by the IFG Commission must be followed. A post-event report may be required. The actual permit will be issued through the IDFG license system. There is no fee for the permit. Any permit conditions will be included in a permit addendum.
