A nonresident member of the Armed Forces of the United States or a foreign country may obtain a resident license pursuant to Section 36-202(s)(3), provided the service member presents a copy of assignment orders (in official form appropriate for the branch of service, such as "Request and Authorization for Permanent Change of Station-Military") that indicate the member is on active duty with a permanent duty station in Idaho at the time of license application. The nonresident active-duty member's spouse and dependent children less than eighteen (18) years of age may obtain a resident license, provided they present a copy of the assignment orders and documentation they are member of the active-duty member's household in Idaho.

Under NO Circumstances will a prior year's Idaho hunting/fishing/combo license be accepted as proof of residency.

This affidavit may serve as documentation that a military member, their spouse or minor child(ren) stationed in Idaho are members of the active-duty member's household, along with Military ID. Together with their spouse and child(ren) under the age of eighteen (18) years of age residing in the household, who have been officially transferred, stationed, domiciled and on active duty in the State of Idaho for a period of thirty (30) days last preceding application shall be eligible to purchase a resident license, as long as such assignment continues.

To purchase resident products active-duty military stationed in Idaho must show:

- Assignment orders (in official form appropriate for the branch of services, such as "Request and Authorization for Permanent Change of Station-Military")
 - This document must show that the military member has been assigned to an Idaho military installation/facility.
- The purchase of resident licenses will be lawful after the military member has been present in Idaho for at least thirty (30) days past the "report for duty no later than" date recorded on the orders.

Assignment orders are not valid if the period of active duty has past or orders show an expiration date that has passed. (i.e. active-duty period of 400 days but the "report for duty no later than date" recorded on orders is 2 years ago, the document is not valid).

Spouse and minor children must show service member's assignment orders and documentation they are a member of the active-duty military members household. Acceptable forms of documentations include:

- Home Utility bill
- Government issued ID with same address as active-duty military member in Idaho
- Military ID card
- Rent receipts or mortgage utility bill

If the above documentation cannot be provided this affidavit may serve as documentation, they are a member of the active-duty military members household.

Under NO Circumstances will a prior year's Idaho hunting/fishing/combo license be accepted as proof of residency.
