**STIPULATIONS - LIVE IMPORT OR TRANSPORT PERMIT:**

1. Live fish or egg import or transport is regulated by Idaho state law (36-104) and codes (13.01.06, 13.01.10, 13.01.11).
2. No permit is required to:
  - Transport fish between Idaho licensed commercial fish facilities, or
  - Transport fish by an Idaho licensed commercial fish facility operator to a permitted private pond.
3. An import or transport permit may only be issued in conjunction with a valid Private Pond Permit and is not transferable.
4. An import or transport permit must be in physical possession at all times live fish or eggs are being imported or transported.
5. Permittees collecting fish from the wild in Idaho for transport must possess a valid fishing license and adhere to all regulations and rules (bag limits, minimum size, gear, etc.). Other legally licensed anglers may assist in collecting fish with the permittee.
6. Illegal release of live fish has serious adverse effects on existing fish populations and on fishing. If you suspect an illegal fish release has occurred or may occur, report it to the nearest Department representative or call the CAP toll-free number 1-800-632-5999.

**SUBMISSION OF APPLICATION:**

A fee is required with application submission (Idaho residents - \$23.50; Nonresidents - \$30.75). Allow up to three weeks for processing. Applications should be submitted to the respective regional office:
